

**RULES AND REGULATIONS GOVERNING THE OPERATION AND CONDUCT  
OF THE RECREATIONAL FACILITIES**

1. BOROUGH PARKS SHALL BE OPEN FOR PUBLIC USE ON A YEAR-ROUND BASIS, WITH SOME AREAS AND FACILITIES NOT BEING AVAILABLE DURING CERTAIN SEASONS.
2. NO PERSONS ARE PERMITTED IN ANY PARK DURING THE HOURS OF DARKNESS, EXCEPT THOSE AREAS DESIGNATED FOR EXTENDED USE ACTIVITIES, OR UNLESS WRITTEN PERMISSION IS OBTAINED FROM BOROUGH COUNCIL.
3. THE ROYALTON BOROUGH COUNCIL MAY TEMPORARILY CLOSE OR CURTAIL ACTIVITIES UPON ANY LANDS OR WATERS OR ANY PORTION THEREOF, WHEN IT HAS BEEN DEEMED NECESSARY TO BE IN THE BEST INTEREST OF PUBLIC SAFETY, CONDUCT, HEALTH OR ORDER.
4. NO PERSON SHALL INJURE, DEFACE, DISTURB OR IN ANY MANNER DESTROY OR CAUSE TO BE DESTROYED ANY PART OF ANY RECREATION, PARK OR CONSERVANCY SITE OWNED BY THE BOROUGH, NOR ANY BUILDING, SIGN STRUCTURE, EQUIPMENT, UTILITY OR OTHER PROPERTY FOUND WITHIN.
5. NO PERSON SHALL REMOVE, INJURE OR DESTROY ANY TREE, FLOWER, SHRUB, PLANT OR GROWING THING OR ANY ROCK OR MINERAL.
6. NO PERSON SHALL KILL, TRAP, HUNT, PURSUE OR IN ANY MANNER DELIBERATELY DISTURB OR CAUSE TO BE DISTURBED ANY WILD BIRD OR ANIMAL WITHIN THE RECREATION, PARK OR CONSERVANCY SITES OWNED BY THE BOROUGH.
7. NO PERSON SHALL THROW, DISCHARGE OR OTHERWISE PLACE IN THE WATERS OF ANY BODY OF WATER ADJACENT TO ANY PARK OR ANY TRIBUTARY, STREAM, STORM SEWER OR DRAIN FLOWING INTO SUCH WATERS ANY SUBSTANCE, MATTER OR THING, LIQUID OR SOLID, WHICH MAY RESULT IN THE POLLUTION OF SAID WATERS; NOR TO DUMP, DEPOSIT OR LEAVE ANY BOTTLES, BROKEN GLASS, PAPER, BOXES, CANS, DIRT, RUBBISH, WASTE, GARBAGE, REFUSE OR TRASH ANYWHERE WITHIN THE PARK OR CONSERVANCY SITES OWNED BY THE BOROUGH; AND WHERE RECEPTACLES ARE NOT PROVIDED, ALL SUCH MATERIALS SHALL BE CARRIED AWAY FROM THE PARK BY THE PERSON RESPONSIBLE FOR ITS PRESENCE AND PROPERLY DISPOSED OF ELSEWHERE.
8. NO PERSON SHALL RIDE IN OR DRIVE ANY MOTOR VEHICLE WHICH IS SELF PROPELLED UPON ANY PARKLAND, EXCEPT UPON THE ROADS OR ON AREAS WHICH ARE DESIGNATED AND PROVIDED FOR SUCH PURPOSES. NO PERSON SHALL TEST, REPAIR, OR WASH ANY VEHICLE OR MECHANICAL DEVICE IN ANY PARK. THERE SHALL BE NO PARKING AT ANY TIME EXCEPT IN AREAS DESIGNATED FOR SUCH PURPOSES. SPEED LIMIT FOR ALL VEHICLES SHALL BE TEN (10) MILES PER HOUR.



9. PROHIBITED ACTIVITIES.

FIRES MAY NOT BE BUILT OR ALLOWED ANYWHERE IN RECREATION, PARK OR CONSERVATION AREAS EXCEPT IN GRILLS OR DESIGNATED AREAS PROVIDED FOR THAT PURPOSE. IT SHALL BE UNLAWFUL FOR OWNERS OF ANIMALS TO PERMIT THE SAME WITHIN RECREATION, PARK OR CONSERVATION AREAS. GAMBLING IS PROHIBITED IN RECREATION AND PARK AREAS. MERCHANDISING, ADVERTISING AND SIGNS ARE PROHIBITED IN THE PARK AREAS EXCEPT WITH SPECIAL PERMISSION OF THE ROYALTON BOROUGH COUNCIL. IT SHALL BE UNLAWFUL TO LAND A PRIVATE OR COMMERCIAL AIRPLANE OR HELICOPTER ON RECREATION OR PARK LANDS.

10. PERSONAL CONDUCT. IT SHALL BE UNLAWFUL FOR ANY PERSON IN ANY RECREATION, PARK OR CONSERVATION AREA TO:

- (1) DISTURB THE PEACE OR USE PROFANE OR OBSCENE LANGUAGE.
- (2) ENDANGER THE SAFETY OF ANY PERSON BY ANY CONDUCT OR ACT.
- (3) COMMIT ANY ASSAULT OR BATTERY OR ENGAGE IN FIGHTING.
- (4) CARRY, POSSESS OR DRINK ANY ALCOHOLIC BEVERAGE, INCLUDING BEER.
- (5) VIOLATE ANY RULE FOR THE USE OF THE PARK MADE OR APPROVED BY THE BOROUGH.
- (6) PREVENT THE USE BY ANY PERSON OR INTERFERE WITH THE USE BY ANY PERSON OF ANY PARK, RECREATION OR CONSERVATION LANDS, BUILDING OR FACILITIES SO LONG AS USE IS IN COMPLIANCE WITH RULES AND REGULATIONS GOVERNING THE USE OF RECREATIONAL FACILITIES.
- (7) ACT IN AN UNLAWFUL, DISORDERLY OR DISRUPTIVE MANNER OR AGAINST THE BEST INTERESTS OF THE AREAS OR OTHER PEOPLE.
- (8) RIDE A BICYCLE ON THE INFIELD OF A BALL DIAMOND.

11. ALL APPLICABLE STATUTES OF THE STATE OF PENNSYLVANIA AND ORDINANCES OF THE COUNTY COMMISSIONERS OF DAUPHIN COUNTY HAVE FULL FORCE AND EFFECT UPON ALL RECREATIONAL AND PARK AREAS IN THE BOROUGH OF ROYALTON.

12. THE ROYALTON BOROUGH COUNCIL SHALL HAVE THE AUTHORITY TO ISSUE A FEE SCHEDULE FOR THE RESERVATION OF THE PAVILION AREAS. SUCH REVENUE SHALL BE USED FOR RECREATION AND PARK PURPOSES WITHIN THE GENERAL FUND.

13. ANY GROUP OR ORGANIZATION RESERVING USE OF THE PAVILION AREA MUST HAVE A RESPONSIBLE INDIVIDUAL APPLY FOR THE USE. THE INDIVIDUAL MUST BE AT LEAST TWENTY ONE YEARS OF AGE AND MUST BE ABLE TO PROVIDE INFORMATION REQUESTED WITHIN THE RESERVATION FORM. ANY YOUTH GROUPS MUST INCLUDE ONE ADULT PER TEN CHILDREN ATTENDING THE PLANNED ACTIVITY.

14. BOROUGH PERSONNEL DESIGNATED BY THE ROYALTON BOROUGH COUNCIL ARE AUTHORIZED TO ENFORCE ALL RULES AND REGULATIONS GOVERNING PARK AND RECREATION AREAS.



15. VIOLATIONS AND PENALTIES

ANY PERSON VIOLATING ANY OF THE PROVISIONS OF THIS RESOLUTION SHALL, UPON CONVICTION THEREOF BEFORE THE DISTRICT JUSTICE, BE SENTENCED TO PAY A FINE NOT TO EXCEED ONE THOUSAND DOLLARS (\$1,000) AND NOT LESS THAN TWENTY-FIVE DOLLARS (\$25), PLUS COSTS, AND, UPON REFUSAL TO PAY THE SAME, TO BE IMPRISONED IN THE DAUPHIN COUNTY PRISON FOR A PERIOD NOT TO EXCEED THREE (3) DAYS. FOR EACH SUCCEEDING OFFENSE, THE MINIMUM FINE SHALL BE INCREASED AN ADDITIONAL TWENTY-FIVE DOLLARS (\$25), MAKING SUCH MINIMUM FINE FIFTY DOLLARS (\$50) FOR THE SECOND OFFENSE, SEVENTY-FIVE DOLLARS (\$75) FOR THE THIRD OFFENSE AND SO ON, BUT IN NO EVENT TO EXCEED ONE THOUSAND DOLLARS (\$1,000) THE STATUTORY MAXIMUM. WHERE SUCH VIOLATOR HAS REMOVED, DESTROYED, DAMAGED, DEFACED OR BEFOULED THE RECREATION, PARK OR CONSERVATION AREA OR THE CONTENTS THEREOF, THE COST OF MAINTENANCE, REPAIR OR REPLACEMENT SHALL BE CHARGED TO SUCH PERSON OR GROUP IN ADDITION TO ANY FINES LEVIED. FURTHER USE OF RECREATION AND PARK FACILITIES MAY BE DENIED TO VIOLATORS IN ADDITION TO THE IMPOSITION OF FINES AND/OR COSTS.
